## Virginia Nuclear Energy Consortium (VNEC) Briefing, April Wade, Executive Director, VNEC

April briefed members Strategic Planning Summit, September 2024. Objectives of the summit was to identify steps to promote Virginia's strength and advantages in nuclear energy related technologies such as:

- Ensuring Nuclear Energy's contribution to Virginia's carbon-free future (how can nuclear energy meet forecasted load demand)
- Prioritization of Nuclear Energy Innovation
- Developing infrastructure and research and development
- Continue developing nuclear education pathways and workforce

VNEC is currently compiling discussion results from the Strategic Planning Summit and will circulate the updated Strategic Plan to Virgnia Energy staff for further circulation to VNECA members in the coming weeks for feedback prior to submission to the Governor's Office.

April also briefed VNECA members on the upcoming Nuclear Energy 101: A Workshop for Virginia Policymakers and Stakeholders on October 10, 2024. For this event, VNEC partnered with the Nuclear Innovation Alliance to host speakers from Virginia's Nuclear Industry to provide deep background on nuclear energy policy perspectives for elected officials, staff, community leaders, and interested policy stakeholders.

# VIN Hub (VINH) update

Bob Bailey, Executive Director, Virginia Innovative Nuclear Hub briefed VNECA members on current initiatives that include:

- VINH partnering with <u>Virginia Energy Workforce Consortium (VEWC)</u> to build out a comprehensive workforce strategy
  - o Education pipeline
  - Strong K12 outreach
- Develop strategy to build out nuclear research capacity in Virginia

- o Stress importance of test reactor in Virginia to strengthen research capabilities
- Look at Virginia Nuclear Technology Supply Chain- for both fuel and component side
