# Tom Dolan, Director of Operations, Virginia Program Office for Recycling & Disposition of SNF

- Presented case on why Virginia is perfect to lead the effort in opening facility for recycling spent nuclear fuel
- Outlined next steps involved:
  - Establish Program Office for Spent Nuclear Fuel Recycling & Disposition
  - Enact detailed program plan
  - Need Virginia Governor and Congressional Delegation to consent to accepting SNF
  - Request VNECA sponsorship at upcoming American Nuclear Society's Winter National Meeting and Expo in Washington D.C., November 17-21

### **VNEC UPDATE- April Wade:**

- Tom DePonty opened the floor for April's briefing of the Authority on the Virginia is Nuclear Summit
  - Tom commended April on her efforts at making the summit a tremendous success. Added comments that the summit was well attended, including representation from both Senator Warner & Senator Kaine's offices as well as by business and institution leaders, which strengthened momentum in the industry.
- April briefed the Authority on key highlights from the summit & panel discussion topics:
  - Summit kicked off with representatives from NEI, ClearPath, & US Nuclear Industry Council providing an overview of the industry and activities going on across the country, which set the stage for the day.
  - Panel Discussions:
    - Infrastructure
      - Principal Assets
      - Discussion questions:
        - What programs absent?
        - How is Virginia positioned to lead?
        - What assets are missing?
      - Virginia can be a hub of clean energy- nuclear, solar, wind, etc.
        - Clean = Clean regardless of generation method if there are zero GHG emissions
    - Workforce
      - 17<sup>th</sup> Energy Career Cluster Education Cluster: Energy
        - Next steps and how companies already working with Virginia Department of Education to get 17<sup>th</sup> Energy Career Cluster in place
    - Research and Development
      - One of the better conversations because it is a hard conversation between the universities and the companies in finding common ground. Defined it as hard because not everyone walked away with the results they wanted, but they were able to vocalize their opinion.
